**LONG-TERM STRATEGIC
COOPERATION AGREEMENT
BETWEEN
HANGZHOU HANGYANG CRYOGENIC VESSEL CO., LTD
AND
KOREA GAS TECHNOLOGY CORPORATION**

March 28, 2016

This Long-term Strategic Cooperation Agreement is made on March 28, 2016

BETWEEN ;

(1) **HANGZHOU HANGYANG CRYOGENIC VESSEL CO., LTD** whose principal place of business and registered office is NO.1 Hongyuan Road, Renhe Subdistrict, Yuhang District, Hangzhou City, Zhejiang Province, P.R. of China (hereinafter called "HYCV"); and

(2) **KOREA GAS TECHNOLOGY CORPORATION** whose principal place of business and registered office is at 119, Naebalsan-Dong, Gangseo-Gu, Seoul, Korea (hereinafter called "KOGAS-Tech");

(hereinafter each called a "Party" and together called the "Parties").

WHEREAS ;

A. In order to further expand mutual cooperation in the field of Large Full Containment LNG Storage Tank, Commissioning and Related Business, HYCV and KOGAS-Tech reached the below agreement after friendly consultations conducted in accordance with the principles of equality and mutual benefit.

B. The Parties have agreed to cooperate on the following general terms and conditions.

IT IS AGREED AS FOLLOWS ;

1. Purpose

1.1 HYCV and KOGAS-Tech cooperate with each other by taking full advantage of their own resources & conditions, for the mutual benefit and joint development.

2. Model of Cooperation

- 2.1 Generally, KOGAS-Tech as HYCV's subcontractor, mainly take charge of the detailed design for Large Full Containment LNG Storage Tank, Commissioning and Related Business and the technical service at key nodes of site construction. But in order to enhance competitiveness in the bidding or if the Bid Inviting Party has other regulations, KOGAS-Tech and HYCV shall participate in the bidding as a union party.
- 2.2 KOGAS-Tech authorizes HYCV as the Exclusive-Agency for all projects of Large Full Containment LNG Storage Tank, Commissioning and Related Business in the area of Zhejiang and Inner Mongolia of China. Without the both parties' written permission, either party is not allowed to cooperate with other parties for the same business in these areas. Only if both parties join in the bidding for new projects in other area of China, the Exclusive-Agency area shall expand.
- 2.3 The cooperative projects are not limited within the specified area of Exclusive-Agency, but applicable for other areas as well. And in principle, each party shall be considered by the other as prior cooperative party for the same business in these areas. Once either party invites the other party for this kind of cooperation, the other party shall confirm its acceptance within 5 working days, upon the acceptance both parties are not allowed to cooperate with any third parties on this project.
- 2.4 In view of that the Project Bid Inviting Party in China normally allows about one month for bidder's bidding documents preparation, both parties shall make the technical proposal and initial material list of Large Full Containment LNG Storage Tank as soon as possible.
- 2.5 Generally, after HYCV provided project information and both parties confirmed their participation for the project bidding, either party is not allowed to give up during the bidding process.
- 2.6 The project detailed work interface division, submission and confirmation of technical materials including drawings, technical regulations, calculation sheet can executed with the reference of the Hangzhou GAS Project, details is to be stipulated by both parties in the contract.

3. HYCV's Rights and Responsibilities

- 3.1 HYCV is in charge of searching information related to Large Full Containment LNG Storage Tank projects, Commissioning and Related Business in China, pre-sales communication with clients and corresponding pre-sales technical service.
- 3.2 HYCV shall provide KOGAS-Tech with detailed project information in English version, including project name, project location, client party and technical parameters, etc.
- 3.3 HYCV owns the Right of Exclusive-Agency from KOGAS-Tech for all projects of Large Full Containment LNG Storage Tank, Commissioning and Related Business in the area of Zhejiang and Inner Mongolia of China. Without HYCV's written permission, KOGAS-Tech is not allowed to cooperate with other parties for the same business in these areas. Only if both parties join in the bidding for new projects in other area of China, the Exclusive-Agency area shall expand.

4. KOGAS-Tech's Rights and Responsibilities

- 4.1 KOGAS-Tech is in charge of providing project technical support to HYCV, in order that HYCV can carry out the technical communication and project pre-sales service.
- 4.2 KOGAS-Tech owns the Right of Exclusive-cooperation from HYCV for all projects of Large Full Containment LNG Storage Tank, Commissioning and Related Business in the area of Zhejiang and Inner Mongolia of China. Without KOGAS-Tech's written permission, HYCV is not allowed to cooperate with other parties in China for the same business in these areas. Only if both parties join in the bidding for new projects in other area of China, the Exclusive-Agency area shall expand.

5. Confidentiality

- 5.1 Without HYCV's written permission, KOGAS-Tech is not allowed to disclose any project information provided by HYCV to any third parties who have no direct relationship with this project.

5.2 Without KOGAS-Tech's written permission, HYCV is not allowed to disclose any technical materials provided by KOGAS-Tech to any third parties who have no direct relationship with this project.

6. Disputes and Arbitration

6.1 Any dispute, controversy or claim for compensation arising from or in connection with this agreement shall be settled amicably through friendly negotiation within 60 days from its existence.

6.2 If the dispute is not resolved within 60 days, the dispute shall then be submitted for arbitration to Singapore International Arbitration Centre. The arbitration award shall be final and binding. The language of arbitration shall be English.

7. Cooperation Period

7.1 Cooperation Period is 2 years, after signing the agreement. Both parties may consult for extension upon the expiry.

8. Amendments

8.1 This Long-term Strategic Cooperation Agreement can only be amended in writing signed by all Parties.

9. Effect & Language

9.1 This Long-term Strategic Cooperation Agreement shall in all respects be governed by and interpreted in accordance with the laws of Singapore. The Agreement is made out in English.

9.2 The agreement becomes effective upon the signatures of both parties.

9.3 The agreement has four originals, two of them for each party.
